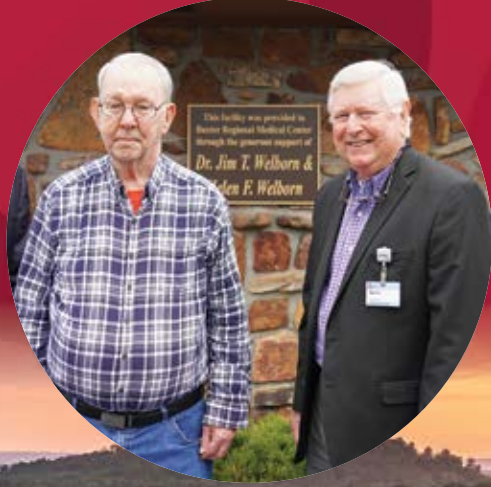

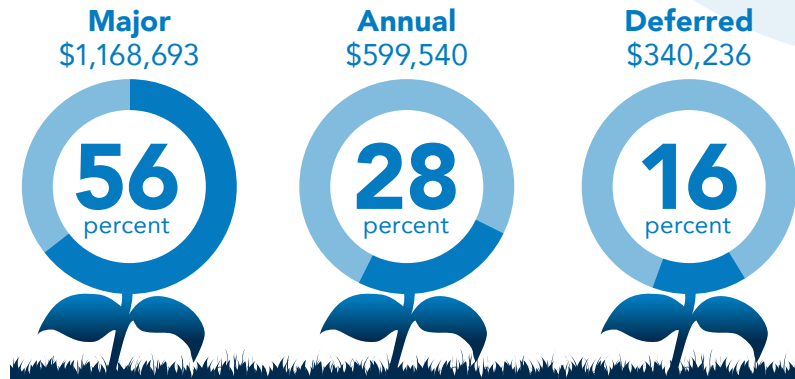

Raymond Ray's COVID-19 Story

Raymond Ray had COVID-19 and was on a ventilator in ICU for 3 weeks (beginning Nov 19th) and was then moved to the 4th floor and then to Acute Inpatient Rehab. He was so appreciative of everything that was done to save his life.

Raymond said after being released, some things were still a little fuzzy -

which can be connected with what they call a COVID Fog.

Raymond is a retired U.S. Army CW2 (Chief Warrant Officer 2). He had been a traveling nurse after the Army, until his wife became ill. Then Raymond came to work as an RN in the BRMC ICU Unit until he retired around 3 years ago.



Mary Ann Sladek's COVID-19 Story

"The nurses in this department are beyond special. Every time they get a call from a patient, they must add a plastic gown over their uniform, put on 2 pairs of gloves, add a special helmet over their cloth covered head and over a mask. The helmet covers their head, face and neck. Their shoes have a cloth covering. In spite of all that, they arrive in the patient's room, all smiles and ready to please the patient in any way they can. When they are through treating the patient with their excellent care, before they leave the room, they dispose of the plastic gown and one pair of the gloves. They add hand cleaner to the second pair and leave the room smiling.

"When the next patient rings for help, they go through this whole procedure again. They do this over and over again throughout their 12-hour shift.

In spite of all this, they give every patient wonderful care, smiling all the while they are with them. I am so thankful for the care I received!"

Mary Ann was so moved by her experience with the COVID Unit at BRMC, she made a tax-deductible gift through the Heroes with Halos program in honor of the COVID Unit Nurses. Mary Ann is also a volunteer at BRMC.

"Our ICU Team has certainly addressed the challenges associated with the COVID-19 pandemic in a proactive and timely manner. We realized the importance of the development of different management protocols early on during the COVID-19 pandemic. We were able to identify concerns prior to the arrival of our first COVID-19 patient and we engaged our partners in care (i.e. - Physicians, respiratory therapy, physical therapy, infection prevention, EMS, nutrition, case management, pharmacy, etc.) almost immediately. We collaborated in many ways to ensure we took a safe, evidence-based approach to ensure appropriate care of those we serve within our community.

"There was a lot to learn in a very fluid environment where the rules seemed to change daily. The ICU Team dedicated themselves to learning all they could about the pandemic. Several of our team

members stepped up to the plate early on to 'volunteer' as caregivers during a time when our biggest fear was that of the unknown. Blessed with the fact that our organization would ensure we received the supplies we needed, education we required, and food to sustain us when we were unable to leave the clinical setting,

we have managed to persevere. The pandemic took an emotional toll on many of us in so many ways and those working in healthcare were no exception.

"We are truly blessed to have donors willing to provide such essential equipment as new

ventilators, UV lighting and personal protective equipment (PPE). This helped ensure the safety and well-being of those whose lives were impacted so significantly by the pandemic.

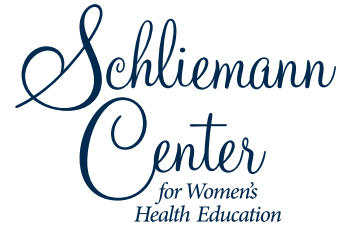
