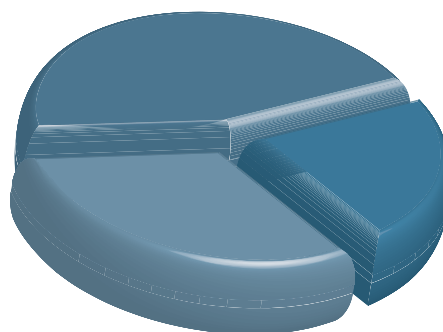

The Focus on Women – Moms & Babies Continues in 2014!

This is Phase 2 of the Building for Babies Capital Campaign – a \$2 million dollar campaign started in 2013 to enhance the care in the Women & Newborn Care Center. With the renovations and upgrades, BRMC is the region’s leader for women and newborn healthcare.

**Help advance the care of women & newborns by buying a block.**

The 2014 Buy-a-Block Capital Campaign was kicked off in January 2014 with the unveiling of a 25 foot by 5 foot 3-dimensional mural on the 2nd floor Women & Newborn Care Center. Local artist Meghan Benham was commissioned to design this mural to depict a child’s playroom filled with building blocks.

The blocks are different colors based on the different giving levels and each level of giving may be paid within 5 years. Each block can be personalized to honor a new family member...or your child or your grandchild.

Renovation of the Women & Newborn Care Center doubled the nursery capacity to 10 Level 2 nursery beds, provided one-room care for mothers and babies to stay together throughout labor, delivery and recovery, advanced technology to improve care and safety in the nursery and enhanced patient education and support.

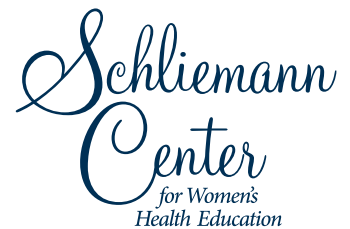


The Reppell Diabetes Learning Center (RDLC) **offers diabetes self-management training through classes, services and support groups** for all ages and all types of diabetes. Recipes, brochures, diabetes magazines, as well as blood glucose monitors are always available.

Working with your physician, the certified diabetes educators and nutritionist, will provide you with all the tools necessary to successfully manage your diabetes and will answer any of your concerns.

Around 8% of the United States population has diabetes. More younger people than ever before are being diagnosed, will be living longer with the disease and dealing with the complications at an early age. The Schliemann Center for Women's Health Education (SCWHE) is a vital part of BRMC's effort to **provide excellent healthcare education for all women, whatever her age or role in life**.

There are a variety of support groups available including, fibromyalgia, menopause and lactation assistance. We offer classes such as Safe Sitter for young girls to obtain the skills necessary to handle an emergency, Breastfeeding & Childbirth to help the new parents-to-be.

Numerous programs are offered at various times in the mornings, afternoons and evenings at the Schliemann Center every month. Some of the programs include Girls Day Out, Schliemann Learning, Girls Night Out and Teen Girls go to College. The Women's Health Forum is held each year to inform area women about topics they feel are the most crucial.

The goal of the SCWHE is to assist all women to be confident, educated and healthy. Most services provided are free of charge. Please call 870-508-2345 for more info.



The Peitz Cancer Support House (PCSH) **provides a complete support services program from first diagnosis throughout treatment and beyond** in a comfortable home-like environment for cancer patients and their family.

Numerous support groups are held at the PCSH including, Men with Cancer, Chatting Needles, Celebrating Life, Caregiver's (for family members or friends of cancer patients) and Breast Cancer. Everyone has the opportunity to share their experiences as well as hearing from educational speakers.

Many valuable services are provided, such as Cancer information binders – each one designed with specific types of cancer, nutritional education, tobacco cessation, exercise programs, wig & turban bank, mastectomy bra bank, and Cancer Support Connections—a program to support newly diagnosed cancer patients through a one-on-one connection with a cancer survivor.

fees, votes for the pets, numerous sponsorships and calendar sales. A total of \$15,639 was raised in 2014 from the calendar project and 100% of all proceeds from this event stay right here in our community and benefit the Peitz Cancer Support House.

### BRMC Employee Fund Drive

In 2014, our remarkable employees once again rose to the occasion with 83% of the staff contributing, pledging a grand total of \$106,892 during the 2014 Employee Fund Drive (EFD). The national average for hospital employees to participate in employee fund drives is 30%. Many of the areas funded (some of which are solely funded by our employees) include the Employee Crisis Fund, Friends Fund, Employee Children and Grandchildren Scholarship Fund, Mountain Home Christian Clinic, Community Health Education and Support Houses and Hospice House. In the 14 years of the Employee Fund Drive, BRMC staff members have raised nearly \$1,400,000!

### Hangin' Out In The Hangar

The Mruk Family Education Center On Aging held a fundraiser called "Hangin' Out In The Hangar". The name was

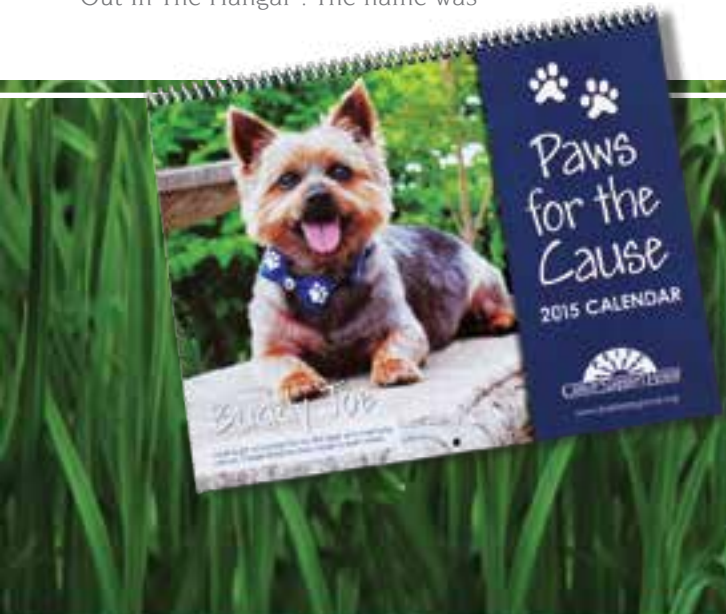

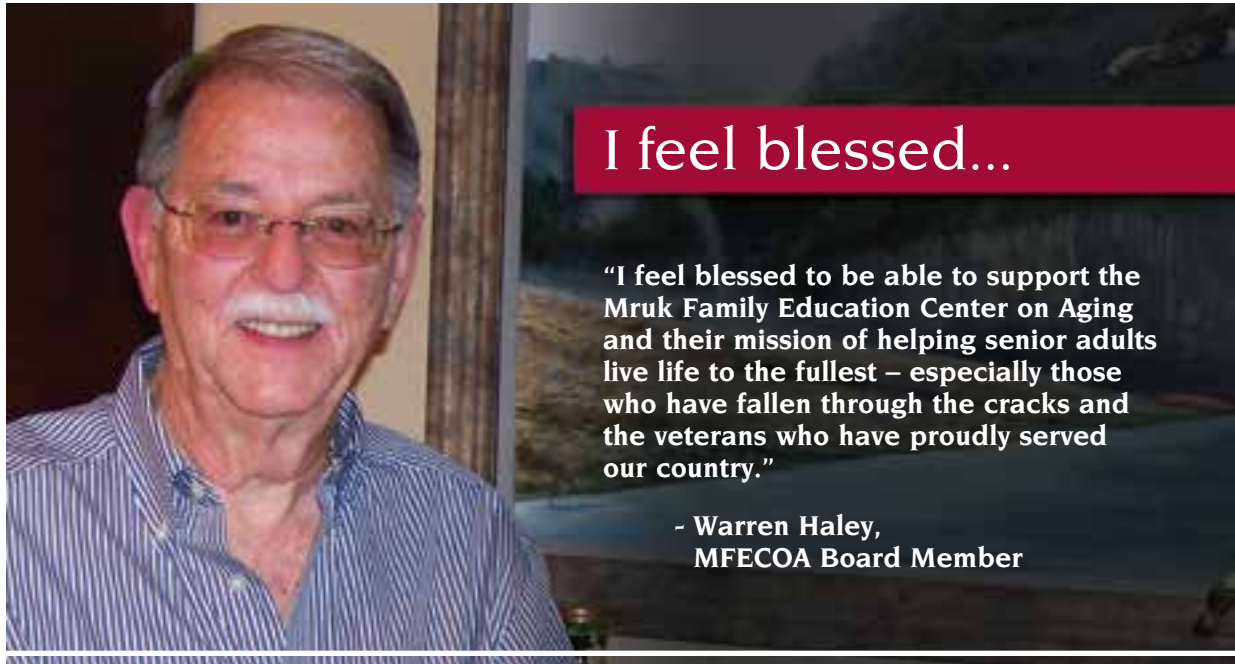
